

PRIVACY POLICY

In Control Physical Therapy, LLC

The following provisions apply to information that In Control Physical Therapy, LLC learns about or obtains from You when You visit the Site. These provisions may be changed from time to time and without notice at In Control Physical Therapy, LLC's sole discretion and as provided by applicable law. This Privacy Policy should be checked frequently for any such changes, but in any case Your continued access or use of the Site shall constitute acceptance of any modifications of the Privacy Policy. In Control Physical Therapy, LLC's use of information gathered or obtained now is subject to the Privacy Policy in effect at the time of such use.

Information we collect

Information You give us. In Control Physical Therapy, LLC receives and stores any information you enter on the Site (for example, when you register for one of our workshops, clinics, events or purchase one of our products) or provide in any other manner. This may include, but is not limited to, Your personally identifiable information, such as Your name, address, phone number, and e-mail address. You can choose not to provide information, but then You might not be able to register or make a purchase online. You are always welcome to make such transactions by mail at In Control Physical Therapy, LLC, 5002 E. Central, Suite B, Wichita, KS 67208 or telephone at 316-691-8885. In Control Physical Therapy, LLC uses the information that You provide for such purposes as facilitating Your purchase or registration, responding to Your requests for information, improving the products and services we offer, and communicating with You. Users may also navigate the website without supplying any personal information.

Automated Information Collection: In Control Physical Therapy, LLC receives and stores certain types of information whenever You visit the Site. In addition to information You provide, we may collect the name of the domain and host from which You access the Internet; the IP address of the computer You are using; and the browser and operating system You are using; the date and time You access the Site; and the Internet address of the Web site from which You linked to the Site. We use "cookies" to automatically gather some of this information. A cookie is a small text file that In Control Physical Therapy, LLC sends to Your computer to collect information about Your activities on the Site. The cookie transmits this information back to the Site each time Your browser requests a page from the Site, and the information is stored to help facilitate Your use of the Site the next time You visit. If You do not want to receive cookies from the Site, You can set Your browser to not accept cookies.

How we use collected information

We use the information You provide and we collect to:

- Administer the Site and diagnose server problems

- Verify Your identity
- Provide You with information about the Site and In Control Physical Therapy, LLC and our products and services; and in order to facilitate performance by In Control Physical Therapy, LLC or You under the Terms and any other agreement You may enter into with In Control Physical Therapy, LLC
- Measure the number of visitors to the Site and how the Site is used, in order to make the Site as useful as possible to our visitors and
- Provide authorities or relevant individuals with information related to the Site as required by law.

Sharing information

In Control Physical Therapy, LLC will not sell or rent your personally identifiable information to anyone. In Control Physical Therapy, LLC may aggregate data about visitors to our website in a non-identifiable manner and use it for a variety of purposes. For example, we may aggregate data for product development and improvement activities. However, it is important to note that no personally identifiable information is available or used in this process. We may also share information collected or obtained from You with others, such as, but not limited to In Control Physical Therapy, LLC's affiliations.

Links on our site

The Site may contain links to other sites. These links are for the convenience of visitors to the Site only, and In Control Physical Therapy, LLC makes no representations whatsoever regarding such other sites. Security

The Site has security measures in place to protect against the loss, misuse or alteration of information under In Control Physical Therapy, LLC's control.

Compliance with COPPA

The Site is not intended for or directed at children under the age of 13. In Control Physical Therapy, LLC complies with the Children's Online Privacy Protection Act (COPPA) and does not knowingly permit registration or submission of personally identifiable information by anyone under 13 years of age.

Subpoenas

In Control Physical Therapy, LLC does not disclose the identities of visitors or users of the Site unless legally required to do so. We will respond to any subpoena received from a government agency (i.e., the Securities and Exchange Commission or law enforcement agencies) without prior notice to You. Unless prohibited by law or by a valid court order, we will notify You of any subpoena received from any other party (i.e., for civil litigation) which requires us to disclose

Your identity, and will wait ten (10) days, or a lesser amount of time as required by the deadline in the subpoena, before providing the information requested by the subpoena.
